

PREVENTING CHILD ABUSE

Internet Safety Training for Parent and Child

We would never suggest that young people avoid social media, but we cannot ignore the clear and present danger of harm online that we all need to be aware of.

The purpose of this session is:

- Learn together with your child what is the underbelly of the internet?
- Change behaviour online and think about the consequences of making a mistake;
- Build digital resilience and become a good digital citizen;
- Learn the pitfalls and how to avoid them

Training options for this course are:

- · Parents attend with their child
- Schools ensure every pupil from years 5 to 11 attend throughout the course of a day and parents attend in the evening for the same training

Suggested duration of this training is 30 minutes to 1 hour for children and 1.5 to 2 hours for parents

The session will cover:

- Who is at risk and the statistics of risk;
- Impact and harm of cyber bullying;
- What is the law, who is accountable and what are the legal age limits?
- As a parent how can I help navigate around harm online?
- What is predatory behaviour on the internet?
- What are the possible consequences of not following the advice?
- How many hours sleep a night do I need to succeed at school?
- What is the negative impact on my health of extreme use of looking at screens?
- How do I know who is contacting me?
- What can happen to my photos?
- What is cyber bullying?
- Sextortion; on line streaming abuse; stalking and how it works
- How to avoid hate crime and trolls;
- What are County Lines?
- What are the various apps and online games needing caution?
- What do I need to know to avoid a crisis occurring?
- What does viral look like, what is the dark web / deep web / surface web?
- Is social media and privacy settings secure and how to stay as safe as possible
